# HUMAN RESOURCES EXCELLENCE RECOGNITION PROGRAM 2019



## **Program Details**

#### **Background and Objectives**

Introduced back in 2014, the ACI Asia-Pacific Human Resources Excellence Recognition Program (HRER) was established to acknowledge airports' outstanding achievements in HR management within the region. Held every two to three years, the HRER aims to encourage continual exchange of best practices in HR among ACI Asia-Pacific member airports to support the development of airport through people.

## **Topic**

The topic of HRER 2019 is "Change Management". The Asia-Pacific region is one of the fastest growing regions in the world, and airports in our region have been transforming themselves rapidly in face of challenges such as surging traffic and evolving demands from passengers. The HR team plays a crucial role to equip and support individuals and the company to successfully manage different changes so as to drive organizational success and achieve the corporate goals in the long run.

#### **Recognition Criteria**

The papers should provide insightful and structural analysis with case studies that demonstrate the airport's recent HR efforts on "Change Management". The papers would be judged by the criteria below:

- Innovation
- Effectiveness
- Applicability
- Proven Contribution to Airport Business

#### **Recognition Categories**

Gold, Silver, Bronze Recognitions will be given to the top 3 scorers based on the above criteria.

#### **Eligibility**

Any ACI Asia-Pacific airport members in good standing are eligible to participate in the program.

#### Costs

There are no entry fees to enter the program.

#### **Submission Guidelines**

Each airport member can submit ONE paper only. All papers must be written in English and should contain no more than 5,000 words within the length of 15 pages, including references and appendices. All papers must be submitted in either Microsoft Word format or as a PDF file.

#### **Submission Deadline**

Each participating airport member must send their papers together with the completed HRER 2019 application form to <a href="mailto:hr-recognition@aci-asiapac.aero">hr-recognition@aci-asiapac.aero</a> on or before 23 November 2018 (Friday) 12:00 noon Hong Kong Time (GMT +8).

#### **Timeline**

The results will be announced in late February 2019 and the award presentation will take place during the 2019 ACI Asia-Pacific / World Annual General Assembly, Conference and Exhibition on 2-4 April 2019 in Hong Kong.
